passed, the person or public body is not entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.

- 2. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
- Any written comment/objection submitted to the Town of Halton Hills regarding this application which is being processed under the Planning Act 1990, may be made public as part of the application process.
