**Q:** How do I make sure my Will isn't challenged?

**A:** The most common grounds for someone to challenge a Will are:

- proper execution;
- knowledge and approval of the contents of the Will;
- fraud;
- lack of testamentary capacity; and
- undue influence and suspicious circumstances.

In Ontario, a properly executed Will requires that:

- The Will must be in writing;
- The Will must be signed at the end by the testator in front of two witnesses while all 3 people are in the room at the same time; and
- The witnesses subscribe the will in the presence of the testator.

If the Will is duly executed (meets the 3 criteria listed above), it will generally be presumed that the testator knew and approved of the contents and had the necessary testamentary capacity.

Whether wanting to challenge a Will or defending a Will challenge, or wanting to have a Will drafted that should withstand a challenge, please contact us.
