white chocolate chips


- 1. Heat oven to 375 F. Line a large baking sheet with parchment paper
- 2. Beat butter and sugar in large bowl with mixer until light and fluffy
- 3. Blend in eggs and vanilla. Add flour, baking soda and salt; mix well. Stir in white chocolate chips and cranberries
- Drop rounded spoonfuls (about 2 tablespoons) of dough 1-1/2 inches apart, onto baking

5.Bake for about 9 minutes. Cool on baking sheet for about 1 minute and remove to wire rack to cool completely

For the third year in a row, Council set a tax levy target of 3.9 per cent for the Town's portiona challenge met by staff through careful planning and analysis.

"It's been a tough budget year," acknowledged Mayor Bonnette. "But I have to give kudos to our CAO and the rest of our incredible staff who presented a budget that balances needs with service demands. I think it is important to note that the Town has held its increase to 3.9 per cent for three consecutive years, and coupled with Halton Region and the school board, the overall increase is just 2.4 per

The budget process began in June and received final approval from Town Council on December 11. "The modest assessment growth in the industrial and commercial sectors—one of the lowest in a number of years-coupled with many non-discretionary increases, prompted numerous discussions regarding priorities and the decisions we must make to meet Council's directed tax levy target," said Brent Marshall, Chief Administrative Of-

Legislated requirements and inflationary increases arising from utilities, supplies, and the Town's benefits provid-

ers all contributed to the 2018 budget pressures. The 2018 Operating Budget addressed a number of Council initiatives including enhanced customer service and communications, the Public Art program, the Cultural Master Plan, the Fire Master Plan, the Corporate Energy Plan, tax relief for eligible seniors and the continuance of operations at the Off the Wall and Open Door Youth Centres.

The Town has been successful in keeping its own tax levy to a modest 3.9 per cent since 2016. In previous years, the rate fluctuated from 4.9 per cent to a high of 7.3 per cent in 2011.
