legal matters | Compensatory Spousal Support

Q

I was a stay at home mother for most of our 20 year marriage. What spousal support should I expect if my husband and I separate?

A

In most cases, the disadvantage arising from the roles adopted in a traditional marriage will be such that a wife without help will never be able to establish economic independence.

In these cases spousal support is payable to compensate the wife for this fact. Compensatory support in the traditional 20 year marriage goes on indefinitely. The Spousal Support Guidelines are normally used to determine the amount based on both parties' incomes. If your husband makes \$100,000.00 and you make \$25,000.00 you can expect your husband to pay you at least \$2,188.00 per month, being the mid rage of the Spousal Support Guidelines.
