

## Georgetown musician releases debut album

### Public Information Meeting. Proposed Changes to Fill By-law

You are invited to attend a Public Information Meeting to be held by the Council for the Corporation of the Town of Caledon to consider possible changes to be incorporated to the Fill By-law. Your attendance and comments at this meeting are welcome as it is your opportunity to learn more about the proposed changes and express any opinions that you may have.

#### SUBJECT PROPERTY

This proposed changes to the Fill By-law affects the entire Town of Caledon.

#### PROPOSAL

The proposed changes include creation of a panel of agricultural expertise to support determinations whether the imported fill will improve agricultural outcomes, a more rigorous application and monitoring process, an allowance for small fill applications outside of agricultural areas and clarity on commercial fill operations.

#### NOTIFICATION

If you wish to be notified of the adoption of the proposed Fill By-law, you must make a written request to the Town of Caledon, Regulatory Services, 6211 Old Church Road, Caledon, Ontario L7C 1J7 or at [bylaw@caledon.ca](mailto:bylaw@caledon.ca).

If a person, company or public body does not make oral submissions at a public meeting or make written submissions to the Town of Caledon before the by-law is passed, the person, company or public body is not entitled to any further notice regarding the proceedings.
