

# Acton man faces mischief, firearms charges

An Acton man has been charged in connection with a Dec. 22 incident where a sticker promoting hate was found on a police cruiser when officers returned to their vehicle after investigating a matter at an Acton home.

Last Wednesday police executed a search warrant then arrested a man.

Charged with two counts of mischief to property, eight counts of careless use/storage of a firearm and ammunition is Robert Teal, 35. He was held for a bail hearing.

Police responded to two youths who were fighting. When they arrived the fight was over, but police report the accused had confronted a 16-year-old Georgetown male in the restaurant who didn't want to fight. The Georgetown teen wasn't injured.

The Acton male is charged with uttering threats, assault and causing a disturbance by fighting.

A PIC is being held on Tuesday January 29th, 2013, to give residents an opportunity to review the Draft Plan of Subdivision and Zoning By-law Amendment prior to Council considering this matter, before it proceeds to the Ontario Municipal Board (OMB) for final approval.

The original application was submitted by Halton Hills Village Homes in 1997, for the lands west of Mountainview Road to Eighth Line, north of Ten Side Road. Phase 1 was approved by the OMB in 2002 and registered in 2005, as Plan 20M-929. Fernbrook Phase 2 was also approved by the OMB in 2011 and registered in 2012 as Plan 20M-1112. The Fernbrook - Chester Parcel was approved by the Town in 2011 and registered in 2012 as Plan 20M-1113. The Phase 3 lands are still before the OMB awaiting final approval.

Town Staff and Representatives for the Applicant will be in attendance to provide information and respond to questions about the proposed project.

Please note this will be a drop-in format and there will be no formal presentation.
