Gloria Sinclair

Born and raised in Georgetown, the soon-to-be 66-year-old Sinclair enters the Halton Hills Sports Hall of Fame as both an athlete and builder for her dedication to amateur golf.

The longtime Club at North Halton member has won several regional, provincial and national titles over the past 25 years, highlighted by her Canadian Senior Women's Team Play championship in 2000 and four Golf Association of Ontario individual and team victories.

Carrying a 5 handicap, she qualified for the U.S. Women's Amateur Championship tournament in 1999 and 2001 and placed 15th for her

category at the British Amateur Championship in 2003.

Sinclair has captured the North Halton women's club championship 20 times and won the senior women's title on 15 occasions.

In 2010, she received the Golf Association of Ontario's Achievement Award for her many accomplishments on and off the course.

The list of Sinclair's efforts as a builder are just as lengthy as her accomplishments with club in hand. She has served as club captain, rules convenor, junior golf co-ordinator and training advisor at North Halton, along with other duties in the Mississauga District and GAO teams, earning appointment to the Ontario Amateur Golf Hall of Fame Selection Committee last year.
