## Malibu earns IIHS 2014 top safety pick

The U.S. Insurance Institute for Highway Safety has named the 2014 Chevrolet Malibu with available Forward Collision Alert a Top Safety Pick.

The distinction requires cars to receive high marks in crash worthiness and achieve a basic, advanced or superior rating for frontal crash prevention.

The crash tests consist of front, side, roof strength and head restraint tests.

In order to receive 2014 Top Safety Pick status, the 2014 Malibu had to offer a frontal crash protection system meeting IIHS requirements as well as

receive a "Good" rating – the highest classification used by IIHS – in four of the five crash tests and no less than an "Acceptable" – the second highest classification – rating in the fifth test.

This differs from the 2014 Top Safety Pick Rating that required a car to receive a "Good" rating in four of the five crash tests and no less than an "Acceptable" rating on the fifth test – without offering a frontal crash protection system meeting IIHS requirements.

The 2014 Malibu exceeded those requirements, achieving a "Good" rating in all five tests.
