## **Proposed Amendment to the Regional Official Plan Greater Toronto Area (GTA) West Transportation Corridor Protection** File Number: RQ54A

The Council of the Regional Municipality of Halton, through its Planning and Public Works Committee, is holding a Public Meeting to provide the public an opportunity to comment on a proposed Amendment to the Region of Halton Official Plan, 2013.

Purpose and Effect: The purpose of the proposed Official Plan Amendment is to amend the Regional Official Plan (2013) to implement corridor protection policies to protect for the future location of transportation corridors in the Town of Halton Hills and Milton, identified in the Halton Peel Boundary Area Transportation Study (HPBATS), as well as the GTA West (Greater Toronto Area) Transportation Corridor Environmental Assessment (EA). The amendment will implement corridor protection on lands within the GTA West Preliminary Route Planning Study Area, and phase the supply of urban employment lands in the area west of Eighth Line, north of Steeles Avenue.

Other Applications: The Town of Halton Hills will initiate a land use planning exercise (Secondary Plan) and a Local Official Plan Amendment for those lands, under the Planning Act, filed at the Town of Halton Hills (File D08/HA).

Note: If you wish to be notified of the adoption of the proposed Official Plan Amendment or of the refusal of a request to amend the Official Plan, you must make a written request to the Regional Clerk at the address noted above.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Halton before the proposed Official

Plan Amendment is adopted, the person or public body is not entitled to appeal the decision of the Regional Municipality of Halton to the Ontario Municipal Board. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Halton before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.
