## Tell the government where to go with its plan

The federal government is asking for input from Canadians as it begins the second phase of a three-part consultation on open government.

This phase of the consultation will be open until the end of June.

The 2014 Open Government consultations are expected to run until the fall in three phases.

According to the Treasury Board of Canada Secretariat, the objective of the first phase of the consultation, which remains ongoing and accessible online at data.gc.ca, is to determine how Canadians can best be engaged and informed about open government.

The second phase is to gather ideas from Canadians about activities that could be in Canada's Action Plan on Open Government 2.0.

Canadians will be able to pose questions and make suggestions online and at in-person consultations, according the federal government.

In the final phase, Canadians will be asked for further input to "refine and strengthen" proposals for the action plan.

Ottawa promised a report on the findings from all three phases would be published later this year and summaries of ideas and comments submitted posted at regular intervals.

Canada's Open Government initiatives are supposed to provide Canadians with more opportunities to learn about government and participate in the democratic process.

Canada joined the international Open Government Partnership in 2012, and subsequently released Canada's Action Plan on Open Government.

The Action Plan is a comprehensive strategy with 12 commitments for advancing open government through open data, open information and open dialogue.
