

# Local theatre companies win recognition at ACT-CO awards

More than 600 actors, directors, members of casts and crews came to recognize their very best at the prestigious Association for Community Theatre-Central Ontario (ACT-CO) Gala—the Oscars for community theatre in Vaughan last week.

Competition was fierce among the 45 production entries. Everyone sat anxiously hoping their showcase masterpiece would possibly garnish them a

coveted nomination or even win them the “Thea”. The local groups did very well in their respective categories.

Georgetown Little Theatre’s comedy, *Always A Bridesmaid* results included: Gillian Taggart won Best Supporting Actress; Janet Goncalves won Best Stage Manager; Anthea Hoare and Pamela Niesiobedzki-Curtis were nominated for Best Costumes, and Michelle Foubert was nominated for Best Lighting.

The cast of GLT’s other comedy, *One Slight Hitch* received a nomination for outstanding ensemble performance.

And its lead Esther Chung was nominated for Best Female Lead, as was Milton Players Theatre Group’s Deanna Palazzo.

In the musical category Globe Theatre’s *Cabaret* did very well. Elizabeth Bell won Best Supporting Female and Cheyenne Harvey received a nomination in this category as well. Mary Udell was nominated for Best Costume Design.

In Drama, Milton Players won two THEAs for *The Unexpected Guest*. Michael Chew won for Best Supporting

Male and Victoria Rykova and Cheyanna Lorimer won for Best Costume Design.

Century Church Theatre in Hillsburgh is also celebrating. In the Comedy category, November’s pantomime, *Snow White and the Famous Seven*, by Jo Phenix, won an Adjudicator’s Award for Ensemble. Erin Montgomery won as Best Stage Manager of a Drama for *Dead on Nine*. Also nominated for this show were Ken Noakes, for Best Supporting Actor, and Martyn Worsnop and Danny Moore for Best Sound Design.

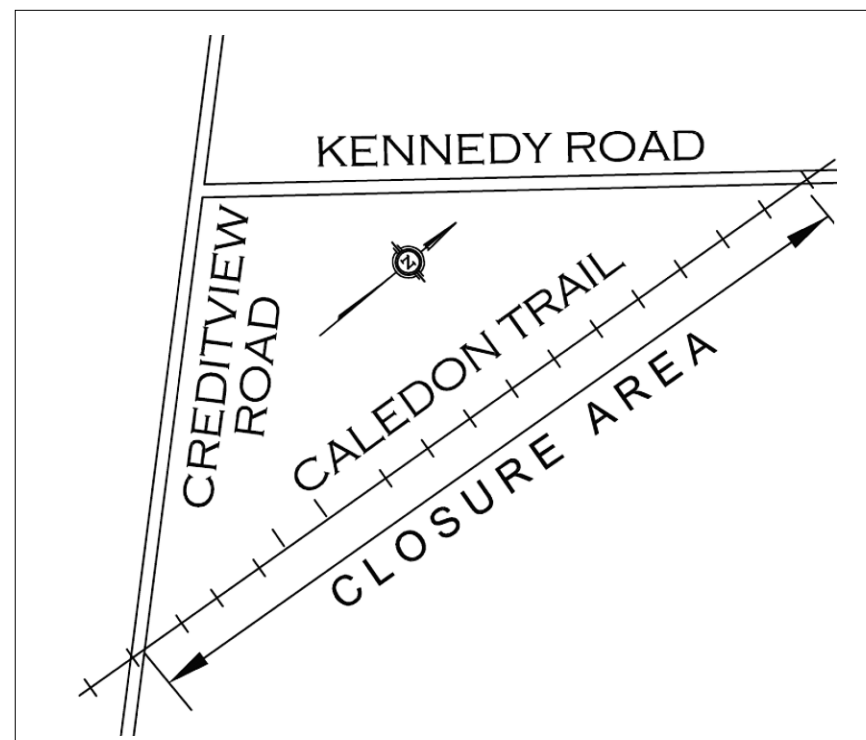
