General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed applications to amend the Town of Halton Hills Zoning By-law 2010-0050, as amended, and for approval of a Plan of Condominium.

The proposed Zoning By-law amendment and condominium applications apply to the lands legally described as Part of Lots 9 & 10, Registered Plan 182, Town of Halton Hills, Regional Municipality of Halton. The subject lands are municipally known as 167-171 Mountainview Road North (Georgetown). Below is a map showing the location of the subject property.

The purpose and effect of the applications are to allow for the development of 11 townhouse units on a plan of condominium.

If you wish to be notified of the decision of the Town of Halton Hills in respect of the Zoning By-law amendment or Plan of Condominium applications, you must make a written request to the Town of Halton Hills - PLANNING, DEVELOPMENT & SUSTAINABILITY DEPARTMENT at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

**NOTES:**

1. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the by-law is passed, the person

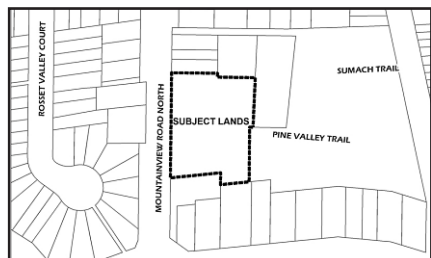
or public body is not entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.

2. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Town of Halton Hills before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
3. Any written comment/objection submitted to the Town of Halton Hills regarding these applications which are being processed under the Planning Act 1990, may be made public as part of the application process.

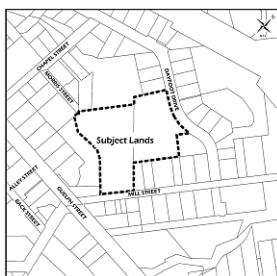
entitled to appeal the decision of the Town of Halton Hills to the Ontario Municipal Board.

3. Any written comment/objection submitted to the Town of Halton Hills regarding these applications which are being processed under the Planning Act 1990, may be made public as part of the application process.
