**Hybrid** theory has many benefits

This week's tip is on equipment, more specifically hybrid clubs. If you haven't got at least one in your bag, you need to do yourself a favour and try one out.

A hybrid is basically a long iron or fairway wood replacement club. There are a couple of reasons why they work so well. First, the shaft is generally shorter than a fairway wood so the golfer has better control over the club

Second, the design of the head places more weight away from the face versus a long iron, which translates into a higher launching club.

Both low and high handicap golfers are seeing the benefits of hybrid clubs. High handicappers are replacing their three and four irons with easier to hit and more forgiving hybrids. The low handicappers are using hybrids to

replace 5-woods, 2-irons and even 3-irons because they can fly the ball into greens on a higher trajectory than their old clubs.

Hybrid clubs are also very versatile. The smaller head of a hybrid allows the club to move through the rough, easily allowing golfers to escape from bad lies. They are also great off the tee on those shorter par fours where accuracy is more important than distance.

Try putting with one when your ball is on the fringe or up against the collar, you will be surprised at how close you can get to the hole. You may even drain one!
