

Purpose and Effect: The purpose of the proposed Official Plan Amendment will redesignate a parcel of land located at 12519 Eighth Line in the Town of Halton Hills from the "Mineral Resource Extraction Area" designation to "Agricultural Area" and "Regional Natural Heritage System" on Map 1, as well as make appropriate changes to the constraint Maps 1D, 1E, 1F and 1G. The effect of this application is to permit appropriate after-uses that are in keeping with the Region's Official Plan.

To ensure all comments are considered, the public is invited to provide written submission on the proposed Official Plan Amendment to Rick Reitmeier on or before July 8, 2015. This submission deadline will permit Regional Council to deliberate the adoption of this Amendment on September 9, 2015.

Note: If you wish to be notified of the adoption of the proposed Official Plan Amendment, you must make a written request to the Regional Clerk at Halton Region, 1151 Bronte Road, Oakville, Ontario L6M 3L1.

If a person or public body does not make oral submission at a public meeting or make written submission to The Regional Municipality of Halton before the proposed Official Plan Amendment is adopted, the person or public body is not entitled to appeal the decision of the Regional Municipality of Halton to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to The Regional Municipality of Halton before the proposed Regional Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.
