Q: Do I Really Need a Will?

A: If you do not have a Will, on death, your property will be disposed of according to the provincial laws of intestacy.

Additionally:

- Your assets may not be distributed as you would have chosen; they may even pass to heirs you did not intend to benefit.
- Your spouse will not be entitled to the entire estate if you were married with children;
- Assets for minor children will have to be paid to the Accountant of the Superior Court. The Office of the Children's Lawyer, maintains these funds while they are minors until they turn 18.
- If you have a common-law or same-sex relationship, your partner could seek financial support from your estate, though he or she has no automatic property rights.

Your estate requires the court to appoint someone who may not be optimal for the role from being unfamiliar with your assets or financial or administration knowledge. That individual may be required to post a financial bond. Additionally, family disputes can occur when a person dies without a Will.
