## Firefighters respond to structure fire on Armstrong Ave.

Halton Hills Fire Department responded to the report of a structure fire on Armstrong Ave. in Georgetown at 8:44 p.m. on Tuesday, Sept. 8.

Staff arrived on scene to a large industrial building with black smoke showing from the roof area, with a strong smell of burning, and alarm bells sounding. Fire staff completed a 360 of the building and noticed smoke coming from the building with a strong smell of burning rubber and blackened windows along the upper wall.

Crews entered the building and found

high heat and a small fire burning under a machine oven. Crews extinguished the fire and shut down the gas supply to the oven.

Cause of the fire was determined to be excess product in the oven, resulting in a high heat build-up.

### NEIGHBOUR PUTS OUT FIRE

Firefighters responded to a burn complaint on Gray Gate, at 10:56 a.m. on Friday, Sept. 11. On scene staff found a smouldering fire, with the neighbour who called putting water on it. The homeowner did have a valid burn permit.

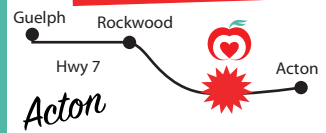

The second instalment of the 2015 Final Tax Bill is due on  
**Monday September 28, 2015.**

#### PAYMENT OF TAXES

- Payment must be received on or before the due date

#### WHERE?

- Finance Department, Civic Centre (8:30 – 4:30 Monday to Friday), or
- Payments may be left at the Halton Hills Hydro Office (no receipts issued)

#### AFTER HOURS?

- Drop Box located next to main entrance of Civic Centre available 24 hours

#### HOW?

- By CHEQUE or CASH
- CHEQUES POST-DATED for the due date or earlier
- INTERAC - in person at the Civic Centre
- By TELEPHONE or INTERNET - Check with your bank for further information
- PRE-AUTHORIZED PAYMENT PLAN: For details please call the Finance Department at 905-873-2601, ext. 2243

#### LATE PAYMENTS?

- A late payment charge of 1 ¼ percent will be charged on the first day of each calendar month until taxes are paid

#### FEES?

- Returned cheques (NSF) \$42.00
- Ownership change per property \$30.00

#### NO TAX BILL?

- Bills were mailed May 25, 2015. Failure to receive a Tax Bill does not excuse the Owner from responsibility for payment, nor relieve him/her from liability for late payment charges. Please contact the Finance Department if you did not receive yours

#### NEW PROPERTIES?

- Newly built properties are likely to have tax bills related to their land value assessment only until full assessment is applied and supplementary taxes are billed. Owners are responsible for taxes billed and should make provisions for the future billing of supplementary taxes

#### SENIOR'S TAX GRANT?

- To qualify for the Senior's Tax Grant applicants must be 65 years of age, own and occupy property in the Town of Halton Hills for one year and be in receipt of the Guaranteed Income Supplement. Applications are available from the Finance Department and will automatically be mailed to those who qualified last year
