A prescribed fee which may be refundable, in the amount of \$200.00 for Mayoral candidates and \$100.00 for all other candidates payable by cash, certified cheque, money order, or by debit, must accompany the nomination form as well as 25 signatures endorsing the nomination. (Please Note: 25 signatures of endorsement are not required for School Board Trustees)

A person who proposes to be a candidate may not solicit or accept contributions for election purposes, or incur expenses, until after that person has filed a nomination paper with the Clerk.
