Halton Hills Public Library has officially announced the One Book One Halton Hills title for 2018: *A Stranger in the House*.

The 2017 suspense thriller, by Shari Lapena, tells the story of Karen who mysteriously leaves home (without any belongings or notifying her husband Tom) and gets into a serious car accident, leading to a head injury and memory loss. Upon returning home after being hospitalized, Karen realizes that something is not quite right, though she cannot remember why she'd left home in the first place.

The title was announced on June 20 at the Wines & Spines event in Acton.

"We are thrilled to announce Shari Lapena's novel as the selected title for One Book, One Halton Hills," said Beverley King, Manager of Community and Adult Services. "Mystery novels never go out of style, and our community will be turning these exciting pages all summer long."

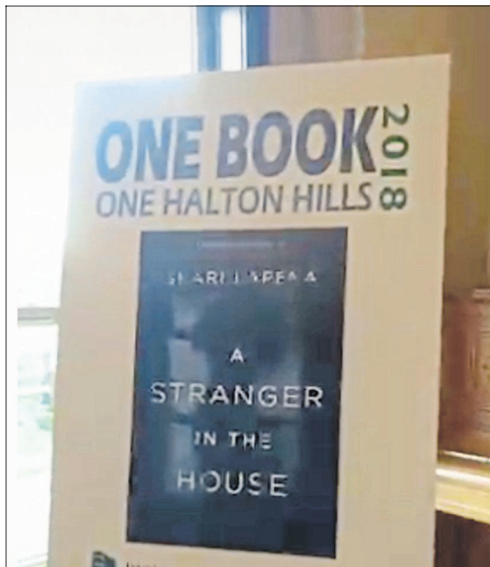

**I just separated from my spouse, and I am being asked to complete a sworn financial statement. Why do I have to do that?**

If child or spousal support or property is an issue arising from the breakdown in your relationship or marriage, then full and proper financial disclosure is extremely important.
