
### **Compost Giveaway**

The final compost material will be a better product by keeping these items out of your yard waste:



No plastic bags

Place yard waste in paper yard waste bags or reusable, rigid containers (no lid) with a "Yard Waste" label.



No plastic plant pots

Place clean plastic flower and plant pots in the Blue Box.



**No plastic toys** Place used or broken pet and/or children's toys in the garbage.
