I am separated, and my former spouse handled all of the household finances. Consequently, everything is in his name, including the house and vehicle insurance. He is threatening to not pay the insurance. Can he do that?

A

Separated spouses should not stop paying for things that they paid for during the marriage until there is an agreement in place. It is wrong, even a source of economic duress for a former spouse to threaten to stop payments, especially for important things like insurance or car payments, even a cell phone. This reflects the imbalance of power there can be between separated spouses. It is bad behavior and can be sanctioned by the Court if the matter is, or ends up in Court.
