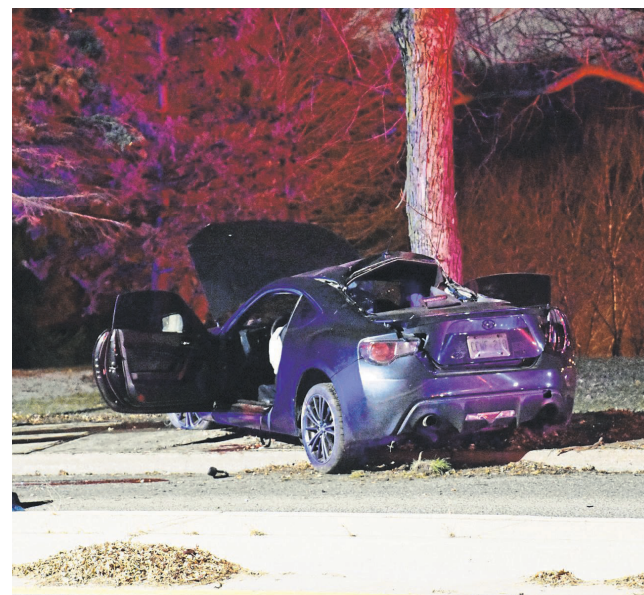

DRIVER IN FATAL CRASH SENTENCED TO 18 MONTHS IN PRISON

An 18-year-old Mississauga man died following this single-vehicle collision in Georgetown in 2017.

A Mississauga man has been sentenced to 18 months in custody, among other conditions, as the result of a fatal street racing incident in 2017.

Mark Abd El Malek, of Mississauga, was the driver of a vehicle involved in a single vehicle collision on Dec. 9, 2017. The driver is alleged to have lost control of the vehicle and struck several light poles

before slamming into a tree.

Despite all occupants wearing their seatbelts, the collision caused the death of 18-year-old Danial Waseem. Abd El Malek was charged with dangerous driving causing death.

On June 1, 2020, Abd El Malek was sentenced to:

- 18 months in custody
- Three years probation upon release from custody
- Five years of driving prohibition
- A secondary DNA order.
