**Q Do I need to sign closing documents in person?**

**A** If you have a closing coming up and you are unable to leave your house to attend your lawyer's office in person to sign documents, you are able to sign closing documents remotely through audio visual conferencing. You should contact your lawyer about how they would arrange that with you and what you need to have access to, such as a printer, scanner, etc. so that you can sign documents and send them back for closing.
