# SIU INVESTIGATION **RULES OFFICERS' FORCE WAS JUSTIFIED**

A Special Investigation Unit (SIU) investigation into an injury sustained during an incident at a Georgetown residence will not result in criminal charges for the officers involved.

On Jan. 22, Halton Regional Police Service (HRPS) officers were dispatched to a residence regarding a report of a 46-yearold man in mental distress with firearms in the home.

The man sustained a fractured kneecap during the arrest potentially related to bullets fired from an Anti Riot Weapon ENfield (ARWEN).

As a result of the investigation, Joseph Martino, director of the SIU, determined no officers involved in the arrest had committed a criminal offence in relation to the injury.

"I am unable to find that the force used against the complainant was excessive," wrote Martino in his decision.

The complainant, one civilian, and six witness officers were interviewed by the SIU.

The subject officer, the officer who fired the weapon, declined to be interviewed and did not submit notes.

The SIU investigates reports involving police where there has been death, serious injury or allegations of sexual assault.

### **Proposed Amendment to the Halton Region Official Plan Applicant: Nelson Aggregates Co.** File No: RQ61A

In accordance with the provisions of the Planning Act, as amended, a complete application has been received by Halton Region to amend the Regional Official Plan (see Key Map to the right).

#### **Purpose and Effect of Application**

The purpose of the application is to amend the Maps of the Halton Regional Official Plan in the manner described below to re-designate or designate 78.3 hectares of land legally described as Part of Lots 1 and 2, Concession 2 and Part of Lots 17 and 18, Concession 2 NDS (former geographic Township of Nelson), City of Burlington, Region of Halton to permit the extraction of mineral aggregates:

- Map 1: Re-designate from "Agricultural Area", "Regional Natural Heritage System" to "Mineral Resource Extraction Area";
- Map 1A: Re-designate from "Escarpment Rural Area" to "Escarpment Mineral Resource Extraction Area";
- Map 1D: Identify the subject lands as "Mineral Resource Extraction Area";
- Map 1E: Re-designate from "Prime Agricultural Area" or otherwise to "Mineral Resource Extraction Area";
- Map 1F: Identify the subject lands to "Mineral Resource Extraction Area"; and
- Map 1G: Re-designate from "Prime Agricultural Areas in the Natural Heritage System" and "Key Features" to "Mineral Resource Extraction Area".

The effect of this application is to permit the expansion of the existing quarry.

#### The Right to File an Appeal

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Halton before the proposed Regional Official Plan Amendment is adopted:

- i The person or public body is not entitled to appeal the decision of the Council of the Regional Municipality of Halton to the Local Planning Appeal Tribunal.
- ii The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
