A 'SUDS'-SESSFUL ENDEAVOUR

BEER STORE RAISES OVER \$100K FOR HOSPITAL WITH BOTTLE DRIVE

Halton Hills residents donated the equivalent of one million empties to the local Beer Store as part of a fundraiser in support of Georgetown Hospital.

The campaign — which ended this past holiday weekend — raised over \$100,000.

"We decided it was a great time to donate to our local charity," said Lance Burrows, store manager at the Georgetown Beer Store.

With about \$20,000 from cash donations, the majority of the funds raised came from bottles, cans and other empty alcohol containers.

Burrows noted, "We're the number one store in the province for donations raised."

With a number of fundraisers shuttered altogether or altered to an online presence during the pandemic, the bottle drive's success is a much-welcomed boost for the hospital.

"We will use the proceeds for the highest priority needs of the hospital," said Sandra Taylor, executive director of the Georgetown Hospital Foundation. "It's vital. A lot of people don't realize the government doesn't cover all of the equipment purchases for the hospital. Without the support of the community, we wouldn't have these pieces of equipment."

Town of Halton Hills Council will conduct a Public Meeting to examine and discuss a proposed application for an amendment the Town of Halton Hills Zoning By-law to change the zoning of the lands to permit business offices, service commercial uses and medical offices within the existing building at 94 Guelph Street.

Legal Notices Required Under the Planning Act:

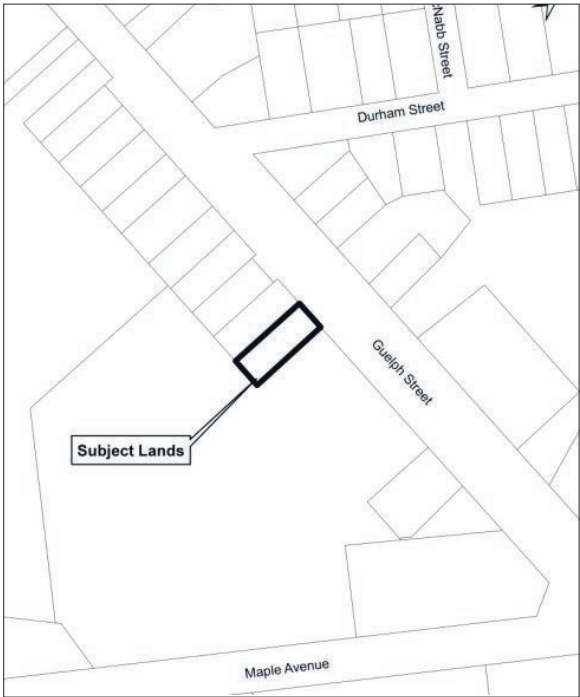
1. If a person or public body would otherwise have an ability to appeal the decision of Town of Halton Hills Council to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the by-law is passed, the person or public body is not entitled to appeal the decision.
2. If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

Any written comment/objection submitted to the Town of Halton Hills regarding these applications which are being processed under the Planning Act, may be made public as part of the application process.
