Help shape your Halton—have your say!

The Provincial Growth Plan mandates that Halton plan for 1.1 million residents and 500,000 jobs by 2051. Halton is reviewing our Regional Official Plan to meet this direction and remain responsive to our community's needs. As part of this review, we have developed different Growth Concepts outlining how and where Halton could grow by the year 2051. We have also prepared Regional Official Plan Amendment (ROPA) 48, which is being considered by Regional Council. ROPA 48 provides direction on how to accommodate future growth in existing urban areas.
