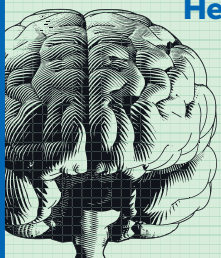

CONSERVATION HALTON AMONG THOSE BEING SUED OVER GIRL'S DEATH

The family of a four-year-old girl who was found dead at Rattlesnake Point Conservation Area in Milton last year has launched a civil lawsuit against the Jewish Family and Child Service and Conservation Halton.

The bodies of Keira Kagan, 4, and her biological father Robin Brown, 35, were found by Halton police at the base of a cliff within the conservation area just after 11 p.m. on Feb. 9, 2020, after they were reported missing following an afternoon hike.

The child's mother, Dr. Jennifer Kagan, previously said that she believes that her ex-husband Brown killed Keira and himself amid a long-stand-

ing custody dispute.

The suit alleges that the Jewish Family and Child Service failed to step up and protect Keira from harm.

Part of the statement of

claim reads that the employees at the children's aid society "knew or ought to have known that Keira
