TRAIL AMBASSADORS HIRED FOR VISITOR OUTREACH

The Bruce Trail Conservancy has hired six Trail Ambassadors to perform visitor outreach and litter clean-ups in three regions, including Hamilton/Halton.

As more people seek the physical and mental benefits of walking in nature, some areas of the Niagara Escarpment have become hotspots, seeing more humancaused impact than the environment can handle, according to a press release issued by the organization.

"The high volumes of trail users include those who may not be familiar with trail etiquette. Litter, trespassing, and other poor behaviours are impacting the trail, the environment, other trail users, and landowners whose property the Bruce Trail crosses."

Together with Bruce Trail Club volunteers, the summer staff will visit busy trail destinations to promote leave no trace practices and safe trail use. They'll also be distributing Hike it. Love it. Keep it Clean badges to those who join them in picking up litter or who are demonstrating low impact hiking.

Tenders must be submitted in the prescribed form and must be accompanied by a deposit of at least 20 per cent of the tender amount, which deposit shall be made by way of a certified cheque/bank draft/ money order payable to the municipality.

Except as follows, the municipality makes no representation regarding the title to, environmental contamination, or any other matters relating to the lands to be sold. Responsibility for ascertaining these matters rests with the potential purchasers. The assessed value, according to the last returned assessment roll, may or may not be representative of the current market value of the property.

Transfers of properties in this jurisdiction that contain at least one and not more than six single family residences and are transferred to non-residents of Canada or foreign entities, are subject to the Province's Non-Resident Speculation Tax (NRST).

This sale is governed by the Municipal Act, 2001 and the Municipal Tax Sales Rules made under that Act. The successful purchaser will be required to pay the amount tendered plus accumulated taxes and any taxes that may be applicable, such as a land transfer tax and HST. The municipality has no obligation to provide vacant possession to the successful purchaser.
