# WEEKLY ROUNDUP: ONTARIO ROLLS OUT ENHANCED VACCINE CERTIFICATES

Following the release of the Verify Ontario vaccine certification scanner app for businesses, fully vaccinated Ontarians can now download enhanced CO-VID-19 vaccine certificate QR codes to be used as a proof of vaccination to enter certain businesses and settings.

"The enhanced vaccine certificates and Verify Ontario app will give our businesses further comfort in their ability to operate safely as we take further steps to protect people's privacy. These certificates remain a key element of our plan to protect the gains we have made while avoiding future lock-

downs," said Premier Doug Ford in an announcement Oct. 15.

The enhanced vaccine certificates can be downloaded from covid19.ontariohealth.ca.

According to the website, the Verify Ontario app scans the QR codes and tells businesses whether a person can enter the venue or not; it won't allow the

government or businesses to track or save personal information. As for the weekly COVID-19 cases, the region's website shows that from Oct. 8 to 14 there were 81 new cases, down from 129 the previous week.

As of Oct. 15, the number of active COVID-19 cases stood at 87 — with 36 cases in Milton, 28 in Oakville, 16 in Burlington, and seven in Halton Hills.

There have been 19,717 cases of COVID-19 since the start of the pandemic, with 19,388 marked as resolved and 242 COVID-related deaths.

# Town of Halton Hills Municipal Class Environmental Assessment for the Stormwater Master Plan 2021

The Town of Halton Hills (the Town) has initiated a study to undertake a Stormwater Master Plan to ensure stormwater (rain) is properly managed and planned for. The Master Plan will help the Town understand how the existing stormwater management network is functioning, identify opportunities and vulnerabilities, and inform short- and long-range planning to improve its stormwater infrastructure. The study results will assist in addressing issues before stormwater assets fail or are otherwise unable to fulfill their intended purpose.

#### The process

This study follows the Master Plan Approach #1 planning process as outlined in the Municipal Engineer's Association "Municipal Class Environmental Assessment" (2000, as amended in 2007, 2011 and 2015) which is approved under the Environmental Assessment Act. The study satisfies the planning requirements for Schedule A and A+ projects and provides the basis for future Schedule B and C projects. Results from this study will be documented in a Master Plan Report that will be made available for public review at the end of the study. At that time, residents, Indigenous communities and other interested persons or groups will be informed of when and where the Master Plan can be reviewed.

How we manage stormwater affects you. Public input and comments are invited for incorporation into the planning and design of this project. Two Public Information Centres (PICs) will be held to introduce the study and present constraints and opportunities related to managing the Town's stormwater system.
