TOWN EXTENDS COVID-19 STAFF VACCINE POLICY TO COUNCIL

As Mayor Rick Bonnette said, "What's good for the goose is good for the gander."

With that in mind, Halton Hills Council has voted in favour of extending the municipality's COVID-19 employee vaccination policy to include themselves, effective Jan. 1.

"We demanded of staff — I think we have an obligation to demand that of each other," said Coun. Moya Johnson, who brought a motion on the topic forward. "This is for the protection of each other and staff and the public that we interact with."

She and Bonnette both recognized that as with em-

ployees, medical exemptions to the policy may be applicable with the proper documentation.

The staff vaccination policy came into effect in October and applies to all employees, student placements, volunteers, contractors and temporary agency workers.

"If the staff are expected to be vaccinated, I think members of council — including myself — should be

as well," noted Bonnette, who seconded the motion.

The policy requires those who haven't provided proof of double vaccination to attend mandatory education on the benefits of vaccines and provide proof of a negative COVID-19 test result within 72 hours prior to entering the workplace. The education component doesn't apply to anyone with a medical exemption.
