WEEKLY ROUNDUP: COVID-19 HOSPITALIZATIONS DOWN 40 PER CENT IN HALTON

COVID-19 hospitalizations in Halton dropped dramatically in the past week, declining by more than 40 per cent.

At press time, there were 28 people in the region's hospitals with CO-VID-19, down from 49 at the

same time a week earlier. Of those 28 patients, 17 were admitted for CO-VID-19 while the remainder were admitted for other reasons and later tested positive.

The region reported six deaths due to COVID-19 over the past week. After going almost a month (Mar. 9-Apr. 4) with no CO-

VID-19 related deaths in the region, there have been 17 since Apr. 5.

The number of lab-confirmed COVID-19 cases also dropped significantly, with Halton reporting 446 over the past week, compared to 659 the previous week.

Among Halton residents ages 12 and older, 94

per cent have had at least one dose of COVID-19, 92 per cent have had two and 60 per cent have had a booster shot.

Among residents between the ages of 5 and 11, 65 per cent have had one dose while 49 per cent have had two doses.

At press time, the region had 11 on-going outbreaks, four in congregate living settings, one at Oakville Trafalgar Memorial Hospital, two at long-term care homes (Extendicare Halton Hills, Maple Villa) and four at retirement

NOTICE OF PESTICIDE USE

From May 16 to October 31, 2022, Halton Region Public Health will be conducting a mosquito larviciding program under the direction of Dr. Hamidah Meghani, Halton Region Medical Officer of Health, to reduce the incidence of West Nile virus (WNV) in the City of Burlington, the Town of Halton Hills, the Town of Milton and the Town of Oakville.

Larviciding in standing water

The biological larvicide, VectoBac 200G (PCP# 18158, granular) or VectoBac 1200L (PCP# 21062, liquid), will be applied to affected standing water on public lands in urban areas, where monitoring indicates that mosquito larvae are present. Signs will be posted at each location indicating when and where the larvicide has been applied.

Larviciding in catch basins

Where monitoring indicates that mosquito larvae are present, the larvicide Altosid Pellets (PCP# 21809, pellet), Altosid XR Briquets (PCP# 27694, ingot) or Vectolex WSP (PCP# 28009, pouch) will be placed by hand into catch basins. All larvicides will be applied by Ministry of Environment, Conservation and Parks licensed applicators or technicians.
