WHEN SHOPPING FOR FINANCIAL PRODUCTS, BE YOUR OWN ADVOCATE

Recent results of mystery shoppers provided Canada's banks with mixed messages, according to Investment Executive.

Three out of every four shoppers reported having a positive experience.

But many shoppers had a negative experience with inappropriate product recommendations, confusing and misleading disclosures, sales pressure and a lack of knowledge from the employee.

Inappropriate product recommendations were reportedly experienced by one out of every three shoppers inquiring about a chequing account. Almost half of the shoppers claim to have found inappropriate recommendations when inquiring about credit cards.

This research by the Financial Consumer Agency of Canada (FCAC) was re-

leased in May.

The FCAC said "bank workers need to be trained to make recommendations that meet consumer's needs, without pressuring them to accept products they do not need or understand. Employee sales targets and incentives should not conflict with these objectives."

The quality of service cannot just be judged by the personality of the person with whom you speak. It is all about the quality of the recommendations.

The part of the survey I found most interesting was the shoppers came away with a pleasant experience, but as for the important aspects, there was much lacking in the quality of service.

It's important that evervone be their own personal advocate.
