# POLICE INVESTIGATE SUSPECTED ROAD RAGE INCIDENT

Halton police are investigating following a suspected road rage incident in Halton Hills on Saturday, Oct. 1.

At around 11 p.m., the victim was driving on Hwy. 7 between Fourth and Fifth Line when an individual in a black sedan to the rear apparently became upset with the victim, police said.

The sedan sped up and passed the victim and it's at this point that a passenger in the sedan allegedly leaned out the window and pointed what appeared to be a firearm at the victim's vehicle.

No shots were fired, and no one was injured during this incident.

# HYDRO CUSTOMERS TO GET CREDIT ON NOVEMBER BILL

Halton Hills residents can expect a credit on their November hydro bill.

The \$19 credit is due to a billing error that Halton Hills Hydro discovered and reported to the Ontario Energy Board.

Halton Hills Hydro has a fixed monthly charge based on a 30-day month. However, the billing system converted it to a daily charge and billed customers for 365 days, rather than 12 months. That resulted in customers being charged an additional five days each year for the past four years.

Halton Hills Hydro conducted a review of its billing system after another hydro supplier in the province reported a similar issue. Halton Hills Hydro corrected the billing in May and issued a letter to current customers Sept. 12, saying that it was working with the Ontario Energy Board to determine the amount of the credit.

It was determined that residential customers would receive a credit of \$19.09 for the overbilling.

Tenders must be submitted in the prescribed form and must be accompanied by a deposit of at least 20 per cent of the tender amount, which deposit shall be made by way of a certified cheque/bank draft/money order payable to the municipality.

Except as follows, the municipality makes no representation regarding the title to, availability of road access, or any other matters relating to the land to be sold. Responsibility for ascertaining these matters rests with the potential purchasers. The assessed value, according to the last returned assessment roll, may or may not be representative of the current market value of the property.

Transfers of properties that contain at least one and not more than six single family residences and are transferred to non-residents of Canada or foreign entities, are subject to the Province's Non-Resident Speculation Tax (NRST).

This sale is governed by the Municipal Act, 2001 and the Municipal Tax Sales Rules made under that Act. The successful purchaser will be required to pay the amount tendered plus accumulated taxes and any taxes that may be applicable, such as a land transfer tax and HST. The municipality has no obligation to provide vacant possession to the successful purchaser.
