I am separated. I had a personal injury matter that settled. Is any of the settlement proceeds relevant to my family law matter?

However, some of the settlement may be exempt from being considered or divided in the family law process. It is usually necessary to get full details of the settlement breakdown, as well as past and future medical documentation if the injured party is taking the position he or she has been and continues to be unable to work.
