HOLIDAY TRAFFIC BLITZ RESULTS 150-PLUS CHARGES

A Thanksgiving weekend traffic blitz by Halton police has resulted in more than 150 charges being laid for various driving-related offences within the region.

Operation Impact 2022 ran from Friday, Oct. 7 to Monday, Oct. 10 and saw officers target impaired, distracted, and aggressive drivers as well as those driving without a seatbelt.

Over the course of four days, members of the Halton Regional Police Service's District Response Teams and uniform patrol officers issued a total of 130 provincial offence notices (tickets) for traffic-related offences to drivers throughout the region.

Another 14 provincial offence notices were issued for driving-related of-

fences where the individual charged will be required to make a court appearance.

Seventy-four drivers received written warnings.

Seven people also face impaired driving-related charges.

"Collisions don't take

weekends and holidays off," said Sgt. Will Clayton, Halton Police Regional Traffic Services.

"The reality is that most are the direct result of a conscious decision that an individual driver has made - be it to speed, to drive distracted, or to drive impaired by alcohol, drugs or fatigue. The Halton Regional Police Service will continue to focus on behaviours that put drivers, passengers and all road users at risk each and every day of the year."

Operation Impact is an annual national public awareness initiative spearheaded by the Canadian Association of Chiefs of Police under the leadership of the CACP Traffic Safety Committee.

Q

I am separated. I had a personal injury matter that settled. Is any of the settlement proceeds relevant to my family law matter?

A

We have handled a number of these situations. The settlement is likely entirely relevant as you have to provide full and frank financial disclosure. However, some of the settlement may be exempt from being considered or divided in the family law process. For instance, "general damages", i.e. damages for pain and suffering, are considered exempt and not subject to division or sharing. Amounts paid as part of the settlement for past and/or future income loss may very well be relevant to issues of determining support obligations. It is usually necessary to get full details of the settlement breakdown, as well as past and future medical documentation if the injured party is taking the position he or she has been and continues to be unable to work. We do a lot of family/divorce law, with offices in Georgetown, Brampton and Caledon East. For now, we are continuing to do most everything virtually.
