I am separated. I had a personal injury matter that settled. Is any of the settlement proceeds relevant to my family law matter?

We have handled a number of these situations. The

settlement is likely entirely relevant as you have to provide full and frank financial disclosure. However, some of the settlement may be exempt from being

considered or divided in the family law process.

For instance, "general damages", i.e. damages for

pain and suffering, are considered exempt and not subject to division or sharing. Amounts paid as part

may very well be relevant to issues of determining

support obligations. It is usually necessary to get

BE PREPARED FOR WINTER EMERGENCIES

Emergencies can happen at any time, but being prepared for severe weather conditions can help protect you, your household and the community.

Stay prepared this winter by following these steps:

KNOW THE RISKS

Be aware of potential hazards and winter weather conditions that can cause an emergency in the community. Halton.ca has an Emergency Alerts and Public Information page to keep you informed of potential emergencies in Halton, and you can check for

winter road closures at Ontario's Travel Information page. Sign up for cold warnings from Halton Region to plan ahead.

MAKE A PLAN

Have a plan in place so you and your household know what to do if an emergency occurs. Your plan should include emergency exits, where you keep essential supplies and who to contact for help. Consider what to do if left without power or running water, and ensure you have food and water stored for 72 hours. Visit our Preparing for Emergencies Information page for more on the types of plans you can have in place, and considerations to be mindful of.

GET A KIT

An emergency kit contains everything you need to keep yourself, your household and your pets safe during an emergency

for at least 72 hours. Your kit should include food and water, medications, a firstaid kit, a flashlight, blankets and any other necessities. Prepare a separate kit for your car, containing items that can help you stay safe during emergencies on the road. This winter, I encourage you to check in on family, friends and neighbours who live alone or may require assistance during severe weather and other emergencies.

Halton police are investigating following the alleged theft of a backhoe from a property in Georgetown. At some point between Wednesday, Dec. 14 and Saturday, Dec. 17 someone attended a property in the area of No. 20 Sideroad and Barraclough Boulevard and cut a chain from a gate to gain access, police

The intruder then allegedly located a backhoe, among various other vehicles stored at the property, and stole it.
