Cops warn of seniors bank scam

The Halton Regional Police Service wishes to warn seniors about the bank inspector fraud scheme.

Recently, there have been a number of attempts at this scheme which have been unsuccessful so far.

The scheme involves a male claiming to be an investigator from their bank contacting elderly victims. He requests their assistance in an internal theft investigation at the bank. The victim is then asked to

withdraw funds from their account and turn the funds over at an arranged meeting place.

The Halton Regional Police wish to warn people not to withdraw money from their accounts for a person purporting to be a bank inspector for their bank. If they receive or have received, similar type telephone calls, they should contact the Halton Regional Police, #2 District Criminal Investigation Bureau at 878-5511, Ext. 22216.
