Suspicious fire guts Hollywood

By the time Halton Hills fire fighters responded to Sunday's 9:15 p.m. fire call at the Hollywood Tavern on Guelph St. in Norval, flames had completely engulfed the building. Fire fighters battled the blaze for four hours before it was under control.

According to a police report, all patrons had left the establishment by 7 p.m., and employees left an hour later, securing all exits behind them. During this time only the bar was operating, since a permit had not yet been issued to operate the kitchen.

The tavern had come under new ownership four months ago.

The Fire Marshall's Office is investigating the incident.



OMB to decide Acton's future development

Development in Acton will be discussed for several months before its fate is finally decided upon by the Ontario Municipal Board.

The board's first hearing on this important Acton issue, held Monday at the Town of Halton Hills Civic Centre, was attended by solicitors for the three major Acton East developers; Rinarin Ltd., Coscan Development Corporation and BondArch Development; solicitors for various other developers in the Acton area; representatives of the Town of Halton Hills, Region of Halton, Ministry of Natural Resources

(MNR), Ministry of Energy and the Environment (MOEE) and members of the general

Town of Halton Hills solicitor, Roger Beaman, began proceedings by outlining the development issue.

Following an agreement with the MOEE regarding the number of permitted housing units, the question of water allocation became a concern and the capabilities of Black Creek to pump the requested additional 250,000 gallons of water had to be examined. "Fish habitat has become a major ingredient," Beaman said. "The MNR and MOEE must decide on this issue."

Another problem regarding water servicing was the Department of Fisheries and Oceans refusal to approve the pumping until an agreement was reached with the region monitoring regarding increased water pumping effects, and liability. At the time of the first OMB session, details of both proposals had not yet been issued.

On Monday, a biologist from the DFO had to be subpoenaed for the afternoon session to answer concerns from the region and the various solicitors.

Edwin De Bruyn, senior fish habitat biologist with the DFO, admitted during extensive questioning from regional solicitor Stan Floras, that a large portion of the DFO's stand was based on only one consultant's report, one report from the MNR and only ver-

bal legal counsel. He further admitted no field studies had been conducted of the Black Creek cold-water fish habitat (which the DFO was particularly concerned about).

De Bruyn reported the DFO was concerned about the increase of effluent discharge, ionized ammonia, the temperature of Black Creek (by one degree Celsius) and residual chlorine from the water treatment plant. He also mentioned the "potential lowering of Fairy Lake water levels (which) would likely result in loss of fish habitat."

Other questions were sidestepped by De Bruyn, who explained he was awaiting direction from ministry staff in Ottawa.

The statements of Wes Lammers, also subpoenaed, suggested the MOEE was more inclined to okay the development, but still required an agreement with the DFO.

Lammers, special projects co-ordinator for the ministry, was to be called back to the OMB hearing July 8 to provide an update, and De Bruyn will be called back the follow50 cents includes G.S.T.
