The region, in its wisdom, acceded to the Regional makes no provision for a trunk line from the lake, up Trafalgar Road, and into our township. Mr. Mohammed floated this gem, officially, for the first time last fall. It is absent in the Region's Development Charges, the process which taxpayers financed to look at the long term expansion needs, over a 10-year horizon, of regional resources, including water.

When regional staff were challenged in committee, by the local ratepayers group in the first quarter of 1992, they assured were Engineering, "...that the many aquifers up there had all sorts of capacity." Our regional representatives

Barbara Halsall is an unpaid, but elected, lobbyist. She has standing in a water debate, such as the recent townhall meeting. P.O.W.E.R. must regard potential deterioration in the Black Creek fish habitat as destroying a key argument in opposing the RSI proposal. In five years of debate, and millions of dollars of time and effort, this unique and singular argument is the sum total of the indifference and ineffectiveness of bureaucracy charged with supervising statutes to preserve the town's water. The stakes go well beyond the immediate

development in Acton.

Finally, Barbara Halsall has promoted the interests of her constituents, I am not one, as avidly as you have lobbied for yours, your advertisers. As such, she merits the same respect you demand in a free press. You, too, must earn this respect by avoiding, "'Tis the tale of a fool, full of sound and fury, signifying nothing."

I applaud your efforts to try and focus attention on the serious situation in Acton. We need the olde Hide House companies in this town. I support and encourage your efforts to help them through this difficult period.

I was frustrated that the people from P.O.W.E.R. felt they had to take this opportunity to promote their view of how development should proceed. This meeting was clearly intended to discuss Acton's current problems and what could be done to improve our economic situation. We spent over half our time listening to P.O.W.E.R. and several council members argue over whose approach was correct.

For the record, I hate dumps - don't want one; I don't want to kill the fish - I love fish; I don't want to drain Fairy Lake - it's one of the reasons I live here; I do want the development in Acton East to proceed with all dispatch. Our town needs to grow. Our businesses need a larger population base to survive. We need more people to support our services and we need them

We elect our councilors and empower them to make decisions on our behalf. We employ at town and region, specialists who have studied the water and sewer situation ad nauseam. They all agree this is a good plan. I say let's get the shovels in the ground, get those houses built and give our community a badly needed and long overdue shot in the arm.

I would remind any navsayers that our downtown

businesses are, for the most part, your neighbors. They work long and hard to make a living. They are the places where we work, where our kids work, who support our sports teams, our scouts, our guides, our schools, our charities and many other worthwhile causes. The closing (hopefully temporary) of the olde Hide House has substantially hurt them.

The loss of the Acton East development would be a further crippling blow. I encourage you to inter-
