

Dollars won't settle dump issue

Despite Rita Landry's doubts, Reclamation System Inc. (RSI) presented five parties with \$85,000 July 30, to cover a portion of the costs incurred during last year's Acton dump site legal struggle. The parties included Landry's group FOAD (Furiously Opposed to Acton Dumping); POWER (Protect our Water and Environmental Resources); Town of Halton Hills; Region of Halton and the Halton Region Conservation Authority.

Landry predicted RSI would appeal the Office of Consolidated Hearings' two-week-old order to partially compensate five of the nine applicants. Despite the turn of events, Landry is not appeased.

"We've (all five parties) spent over three quarters of a

million dollars in legal costs, and they only have to pay \$85,000," Landry said. "We shouldn't have been at the hearing in the first place." Landry explained RSI did not have enough supporting paperwork to permit turning the Acton Quarry into a landfill site. She is frustrated because it seems RSI will be given another opportunity to submit its proposal.

Although the Town of Halton Hills received \$19,455, after submitting close to \$500,000 worth of costs to the hearing board, Ray King, town administrator, was understanding. "This amount only covers a specific part of the process," he said. A letter from the Office of Consolidated Hearings, stated the amount will cover costs procured through the "preparation and attendance of the jurisdictional motion" associated with the 1992 hearing. Mostly, the amount covers solicitors' costs prior to the hearing.

King added engineering and legal costs accumulated during the entire Acton dump issue have not been recognized, but "there's a good possibility the majority of the remaining costs will be looked at again at a future hearing."

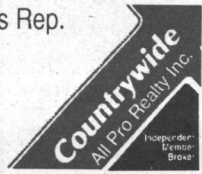

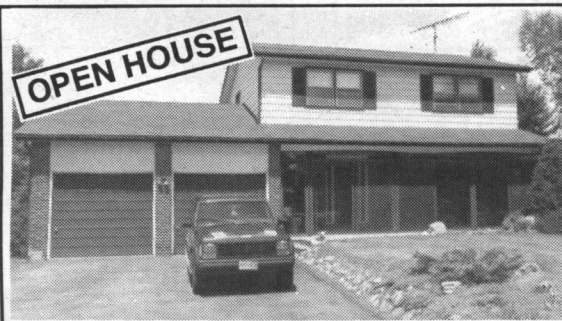

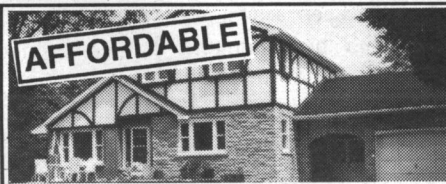
