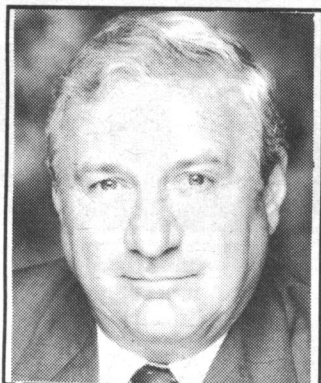


## Liberals offer a safe and secure future

Throughout this election campaign, debate has been focused on the Tory mismanagement of the economy, on the deficit, on unemployment and on the threat of social programs being slashed. I think we need to pay more attention to the real impact of these issues on the ordinary Canadian.

For instance, Canadians are demanding justice system reform. People throughout Halton-Peel tell me that they do not feel safe on their streets and in their homes. Some believe that there is more justice for criminals than for victims.

There is a direct connection between crime and violence and tough times. But the Tories do not seem to understand, nor care, about the extent that people have been hurt, and will continue to be hurt, by a slash-and-burn economic philosophy. Jobs and social programs will fall, but crime and violence will rise as tough times become even tougher.

The ability of any political party to govern Canada should not be judged solely on the bottom line of a financial statement. The Liberal Party puts people first in all its plans. Job creation and deficit reduction will attack the illness of poverty while reform of the justice system will treat one

We are committed to strengthening the Young Offenders Act to deal sternly with the most serious crimes and repeat offenders. Women and children will have greater protection from violence and abuse. There will be more services for battered women and their children. And we will target violent pornography and the exploitation of children.

We will toughen gun control laws. We will consider sending sex offenders who are not rehabilitated at the end of their sentences to secure mental health facilities for further detention. A national crime prevention council will be created and we will undertake comprehensive reform of our sentencing system.

Again, these and other proposed reforms to the justice system which we have spelled out in our campaign literature are not the whole answer to the problems of violent crime in our society.

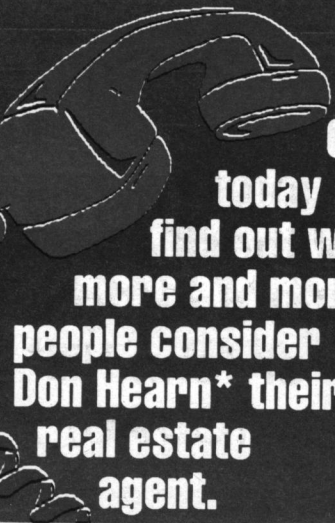

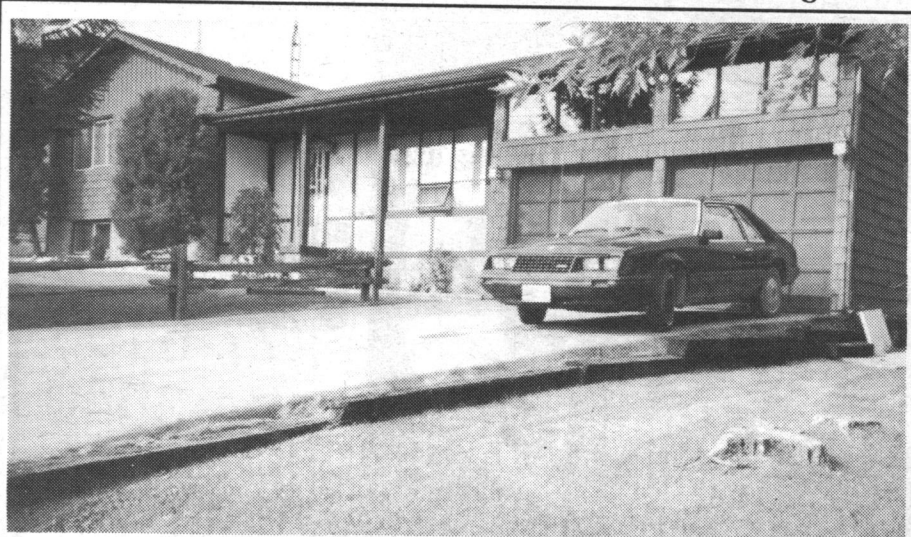
