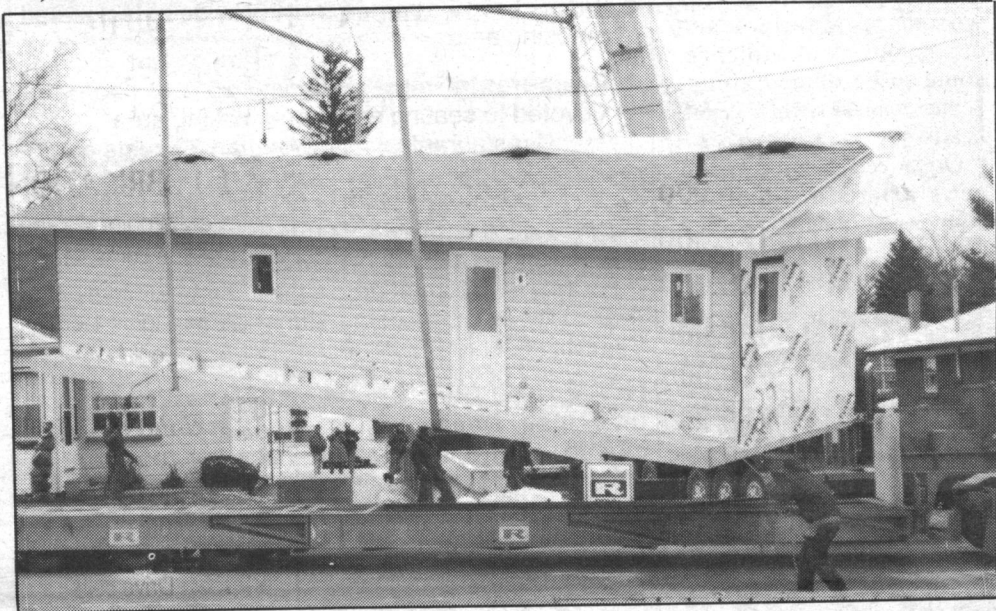

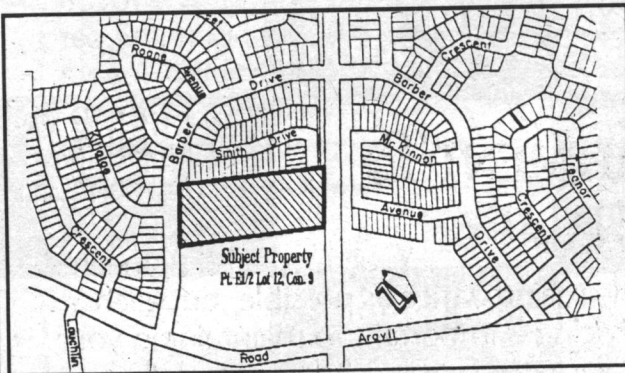

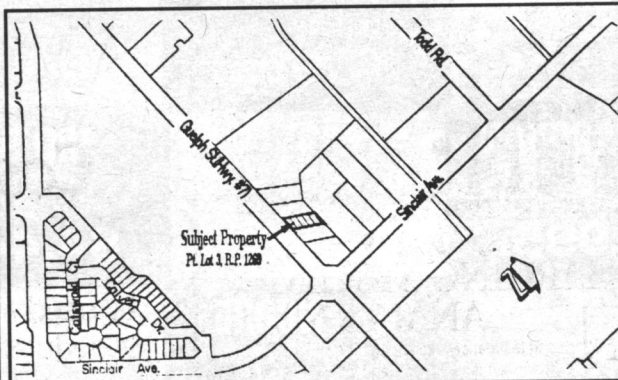

Dog licenses for 1994 are now on sale at \$15.00 each. By-law No. 90-163, as amended, requires that all dogs in Halton Hills must be licensed before February 15th of each year, or within seven (7) days of being acquired.

Dog licenses are \$20.00 per dog if purchased after February 15, 1994, not including any penalties or fines which may be imposed by the courts for conviction of an offence under The Animal Control By-Law.

SENIOR CITIZENS who are 65 years of age or older, upon proof of age, will be charged a license fee of \$10.00 for each dog.
