Here Comes Christmas, Here Comes Year End, Here's What's Left of Tax Planning

Tis the season to be jolly and to take final steps to fend off the tax man!

Unfortunately, all the holiday cheer and hub-bub can take away from the time required for effective personal tax planning. Besides, tax planning is not nearly so much fun! A little bit of time invested in quarterly planning can make this experience a quick and easy routine, with significant financial benefits.

We believe that the government will be taking more from individuals in the form of direct taxes, regulated prices, the elimination of tax based incentives, or any other means open to one's imagination.

The following calendar outlines some important personal tax planning strategies. Keeping more of what you earn will be more challenging as the 90's unfold.

Before Year End

update your calculation of taxable income and tax liability and adjust your final installment payment.

consider selling securities with accrued losses to offset current year capital gains or to create losses that can be carried back to prior

consider selling securities with accrued gains to maximize utilization of your capital gains exemption (under current tax law this is \$100,000 for each individual)

· have interest bearing securities converted to capital gains where possible.

· to obtain a deduction for the current year, pay your deductible expenses and make charitable donations before the end of the year.

· if you are self employed, pay yourself sufficient salary/bonus in 1993 to create the earned income necessary to maximize your

1994 registered retirement savings plan (RRSP) deduc-

tions. · if you have a business, split income with family members. The salary, taxable to the recipient.

 if you turned 71 in 1993, make your annual RRSP contributions before the end of 1993, your RIF must commence in 1994.

 if you have a shareholder loan (other than a housing loan, certain share purchase loans, or a car loan) that was made in the company's previous taxation year, ensure that it is repaid before the end of the company's current taxation year to avoid income inclusion for the full amount of the loan.

you should have your Revenue Canada Tax Assessment statement informing you of your RRSP contribution limit for

During the Year

consider making your 1994 RRSP contribution early or maintain your monthly RRSP invest-

invest in limited partnerships to both make money and reduce taxes paid. This is especially appropriate for people who have maximized their RRSP contributions.

• use spousal RRSPs to split income

invest your family allowance in the child's name. · claim the charity tax

credit along with all other allowed tax credits. • split the CPP with your

spouse where applicable.

 consider crystallizing your small business \$500,000 capital gain exemption to avoid losing the potential capital gain in the face of government leg-

· shareholders of corporations eligible for small business deductions should receive dividends instead of salaries.
