Neighbors in doghouse over noise

The legal posse has been called in to persuade Town of Halton Hills councillors to reject the licensing renewal of an Acton kennel owner who has repeatedly violated noise By-laws.

On Oct. 25, Maurizio Bartucci was advised by councillors the illegal proximity of his Dublin Line kennel to the property line would be disregarded with the stipulation Bartucci must make a "realistic attempt" to resolve the noise problem. Neighbors had complained about the barking and yelping of the dogs, and the yelling of the dog-keepers.

A committee had been set

up to draw up revisions to the existing Animal Control By-Law, specifically the description of adequate facilities for dogs, and the maximum number of dogs at a kennel. The task of the committee has not yet been completed, but neighbors are worried their concerns will be overlooked and a renewal licence will be issued.

A letter provided at Monday night's council meeting to Town of Halton Hills councillors from Barnet Kussner, solicitor on behalf Bartucci's neighbors, suggested "prior to renewal of Mr. Bartucci's kennel licence, a hearing be held before Council, or such

committee as Council may direct, to determine whether the kennel licence ought to be renewed in view of these clear violations which the Town itself has acknowledged."

Town clerk, Janet-Lunn Stewart stated a hearing would be premature because the By-law was currently being amendment. She added Bartucci was the only one who could request a hearing.

Lunn-Stewart concluded by stating kennel licences would not be issued Dec. 31, pending the committee's recommendation, and kennel owners will be notified of this arrangement.
