Water devices mandatory?

Halton Hills Councillors want to know if they can force local developers to install water-saving devices in all new housing subdivisions. Halton Region already has a planning provision that requires developers to install things like special shower heads, toilet dams and nozzles that cut down on water consumption and some Town Councillors want the requirement in local bylaws as well.

Town grants may be cut

A Halton Hills Coucillor's attempt to eliminate all Town grants to local organizations was dismissed by Acton Councillor Norm Elliott as "trying to kill a mosquito with an elephant gun." Councillor Ron Chatten suggested cutting the grants as a cost-cutting measure but Elliott noted that only \$4,500 of grant money was allocated last year and suggested Chatten's idea was "much ado about nothing" and would not amount "to a hill of beans" in the overall budget picture. Councillors decided they would not freeze or cut grants but would send letters to only those groups that received grants last year. They will be told when grant applications must be submitted and warned not to automatically expect to receive what they got last year, or any money at all.

Two Oakville Councillors have joined the push to have Halton Council take another look at the issue.


Parkland contribution held for Blue Springs

Acton Blue Springs Developments doesn't have to pay a \$73,000 cashin-lieu of parkland contribution for its Turtle Lake and Trillium Terrace housing plans until the end of December.

At Blue Springs' request, and with Town staff support, Council voted to extend the drawing on Blue Springs' letter of credit past the Saturday, Oct. 31 deadline. Town staff said there is no immediate need for the money, which is earning the Town a very favourable rate of interest.

Rennie offers to explain fee

Acton Councillor Gerald Rennie has offered to meet with an Acton man upset with Town plans to spend \$80,000 on a consultant to compile a Master Parks plan. After reading about the move in the Tanner, Bruce MacPherson questioned why Town staff could not do the job, expecially in these times of fiscal restraint. Rennie told Council that if MacPherson had difficulties with the decision to hire an outside consultant that he will send him a copy of the study's terms of reference.
