Public meeting called on plaza proposal

An Acton East developer's appeal for action prompted sympathetic Halton Hills politicians to schedule a public meeting no later than Jan. 4 on a proposed major commercial plaza in Acton East.

At Town Council Monday night, Coscan Developments Corporation persuaded Halton Hills politicians to stop delaying their proposal and let the public comment on plans for a 77,000 square foot plaza with a major food store at the south east corner of Churchill Road and Highway 7.

Coscan lawyer Gordon Petch pleaded with council to end four years of delays and over the strenuous objections of Town staff, Council agreed to hold the public meeting.

In making his plea Petch outlined the long and complex history of the proposal which he said got caught up in Town land use and an implementation study.

"We still have an application from 1988 outstanding on the shopping centre. It's 77,000 square feet and we have a tenant who is committed to getting this plaza and the food store built," Petch explained. "It means an opportunity for the

developers and the town. There is revenue and jobs being lost by the delays and we keep saying we want a public meeting. We aren't here to dicker but we can't sit here waiting for the rest of the world to unfold. We're not asking you to approve anything but just give us a chance so that we can hear from Council at a public meeting and win or lose we'll take our lumps or our benefits, but please let's get through the process."

Town planning director Ian Keith opposed calling for a public meeting with outstanding matters involving access to the site from Highway 7 and storm water management issues. Keith told Council it would be inappropriate and premature to call the public meeting without having all the necessary information.

"It would be wise and prudent to have all of the comments from the Province and have the land use and implementation studies before you make a decision to go to a public meeting.

Keith told Council they would have the land use study and implementation plan before them in December and urged them to wait until they had that information before calling a public meeting.

Acton councillor Norm Elliott argued for getting on with the process and said it was frustrating beyond words for Acton residents and developers.

"There has been virtually no development in Acton for years. The Coscan proposal is one of the most promising. We have enough information to go to the public and somebody has to make a decision and let some development proceed."

Following Council's decision to send the proposal to a public meeting, Petch said Coscan was very pleased with the outcome.

"I think our plan unfortunately got involved in a lot of 'planning.' Everybody though it would be nice to have an implementation study and that took two or three years. Then everybody wanted a land use study and at the same time other people were challenging the local urban boundaries. There's been a great cost and loss of revenue and a delay of 300 jobs for the Town because of planning. You can only plan so long and we can't go any further than just signing letters of intent with tenants until we get Town approval."


