

Babysitter freed on \$25,000 bail

A 30-year-old Acton babysitter, charged with manslaughter and aggravated assault in connection with two infants in her care, has been freed on \$25,000 bail.

In releasing Heather Holmgren yesterday (Tuesday) afternoon, a Milton court judge ordered that she live with her parents in rural Georgetown, and have no contact with any child except her own infant daughter, under terms of the Halton Children's Aid Society.

Described by a neighbour as "soft-spoken," Holmgren was charged with manslaughter in connection with the death of a 6month-old Acton boy she was looking after. She also was charged with aggravated assault involving a 6-and-a-half-month-old girl she was babysitting.

Police arrested the woman Monday afternoon after receiving results of forensic tests.

Police will not identify the victims, the cause of death or injuries.

Police report that on Monday, Jan. 18, an Acton woman called 911 and said that the infant boy she was babysitting had stopped breathing. The baby was taken to Georgetown Hospital and transferred to McMaster-Chedoke Hospital, where he died the next day.

A post-mortem did not reveal a cause of death and forensic tests were ordered. Those tests indicated the infant had been assaulted.

On Tuesday, March 23 the same woman was babysitting a 6-anda-half-month-old girl who became ill and was taken to Georgetown Hospital by ambulance and then Please turn to Page 14

The Town and Rowe's lawyer were in Milton Court on Monday arguing their cases.

Following the three-hour hearing, Town counsellor John Schaljo said the case is unique because if the Judge rules against the Town, it would mean a significant change in the tax sale process for all municipalities.

Lucretia Rowe, 83, is the executrix of the estate of Christopher Row, a United Empire Loyalist, who bought a mill site on Fairy Lake in 1851.

In assembling land for a park, the Town discovered the property had never appeared on a tax roll.

It was placed on the roll in 1990 and notice of the tax sale was sent by registered mail to "Christopher Row, General Delivery, Acton."
