taxes.

Unlike property taxes, business taxes are due on demand, and currently the Town does use bailiffs to collect owed taxes, but not actually seize assets.

Unpaid business taxes account for \$302,000 of the total \$4.1 million in unpaid taxes.

Water woes won't go away

Alarmed Acton politicians want a special high-level meeting to deal with what they call Acton's water crisis.

New restrictions from the Department of Fisheries and Oceans and Ministries of Environment and Natural Resources place severe

restrictions on the amount of water the Town can take from Fairy Lake for new development, and the quality and quantity of water it can discharge into the Black Creek.

Acton Councillors want to meet with the agencies involved to work out a solution that will allow the Town to grow by 2,500 people to a population of 10,000.

Counc. Norm Elliott said everyone is frustrated with the delays and setbacks.

"We've been hearing the same story about no water for 20 years," Elliott said.

"We have to focus on this prob-

lem and get some growth because no change is death."

Outstanding taxes concern Town

Town officials are "concerned" with a steady increase in unpaid property taxes.

Of the \$44.4 million the Town school boards, Region and itself. requested from taxpayers last year, and was owed from previous years, \$4.1 million is still outstanding.

That's 9.9 per cent, or almost \$1 million more than the year before.


The Town collects taxes for the

Deputy treasurer Grant Usher said the increase in unpaid taxes is a sign of the times.

"With all the unemployment, it's hard to collect the taxes, but you've got to use some compassion," Usher said in an interview last Wednesday.

The Town charges a 1.25 monthly interest rate penalty, and after three years, if taxes are not paid, the Town can sell residential properties to recover the money.

Usher said that has happened only four times in the past 25 years because in almost all cases owners paid the arrears when warned that the Town was taking action to claim owed taxes.
