# Buckle up, Acton!

For the next couple of weeks Halton police will be paying special attention to seat-belt enforcement and I hope they zero in on parents who don't buckle up their children.

It makes me cringe when I see young babes and children sitting on a passenger's lap, standing on the front seat or playing in the back of a van or station wagon. Their parents made a conscience decision not to buckle up for whatever reason, but the children don't know the risks — or the law.

Statistics show that drivers who do buckle up, even if it is to avoid a fine, are more likely to buckle in their children.

With an aggressive combination of public awareness, education and enforcement, police are aiming for a 95 per cent seat-belt use compliance rate by 1995.

For drivers not convinced to buckle up by the potential of a \$90 fine, there are some sobering statistics. Unbelted drivers are 15 times more likely to be killed and five times more likely to be hospitalized than belted drivers in an accident.

There have already been six traffic fatalities in Halton this year and police report that several of the victims would be alive today if they had been wearing their seat belts.

In any given day there are over one million drivers and passengers on Ontario roads who are not buckled up.

Profiles of infrequent seat belt users show they are risk takers — drivers who are more likely to be in collisions, are more likely to drive when impaired and drive frequently or for long durations.

If all the valid arguments for buckling up don't work, maybe getting pulled over and being given a ticket will.

## Time to butt out

Despite irrefutable evidence that tobacco-use diseases are the No. 1 health problem facing Ontario, Town Councillors have watered down a no-smoking bylaw designed for public places.

Although smoking will be banned in retail stores, shopping mall concourses, service lines, reception areas, elevators, bowling alleys and health facilities, Councillors rejected staff recommendations to outlaw smoking in amusement arcades, hairdressers and barbershops.

Smoking will be allowed in restaurants, but the owner will have to set aside a no-smoking section, not 50 per cent of the floor space as recommended by staff.

As a former smoker, I want all the protection I can get against second-hand smoke and this by-law isn't going to give it to me.

### Seventh anniversary

To the Editor,

A day to remember — April 26, 1986. It has been seven years since the explosion of the Chernobyl nuclear power plant rocked the world.

Today more than three million people continue to live in areas contaminated by dangerously high levels of radiation from Chernobyl, and most of the food available for them to eat has been produced on contaminated soil. Today the "Children of Chernobyl" and their families continue to suffer the consequences of the tragedy that began on April 26, 1986.

Following this disaster, the inchildhood cidence of

hematological and oncological disorders has risen dramatically. Other children exhibit recurring headaches, nosebleeds, hair loss and increased susceptibility to pneumonia and other infections as a result of radiation-reduced immune system response. Doctors in the contaminated areas indicated that the children must leave these zones for six to eight weeks each year if they are to have any hope of

avoiding serious illness. For millions of people — for whole generations in Belarus — April 26, 1986 issued in a new age, an age of Chernobyl grief. It brought irretrievable losses, crushed lives and great pain and suffering. On this, the anniversary of the Chernobyl tragedy, find out how you can make a difference.
