

"This unfortunate decision will affect many local customers and put two full-time and six part-time employees out of work," said Durno Monday.







Businessman believes development is crucial

Last week, Council heard a proposal for the development of an estate subdivision in the 17 Sideroad and Milton Town Line area.

Applicants Jack and Jane Williams, owners of the property, were asking for an amendment to allow the development of a 20-lot rural estate subdivision.

Although many residents of the area are not in favour of this amendment, local businessman Alec Acton." Kitson believes the development will only benefit the community.

"People in Acton need to work and spend money in Acton. The development would be a positive message for the community," said Kitson, vice-president and general manager of Acton Precision Millwrights.

"The development would create a win-win situation. If they have satisfied all of the requirements then Council should not

stand in the way of this economic stimulus for Acton," explained Kitson in an interview earlier this week.

"The Williams' have already stated that they will be using local construction companies for the project, and that will bring money into Acton. The new residents could easily influence business in the town by opening stores or sharing ideas. They could bring as much as \$1,000,000 annually to local restaurants and shops in

Kitson is hoping that Council will see past the concerns of the local residents and pass the amendment on the basis that this development is needed for the economic growth of Acton.

"I think and hope Council will do the right thing. They really do not need to worry about the effect of this. It is a good development and good for the town."

Council is expected to debate this issue as early as March.
