the town, often at odds with pressure groups. It's a difficult job since most of the members of council are Georgetown-oriented. For them, Acton's problems must seem secondary.


At no time was this factor more in the spotlight than when a candidate for a Ward 3 Georgetown council seat made some petty, uncomplimentary remarks about Acton, dismissing our community as a wasteland for shopping and designated Prospect Park and Fairy Lake as harbours for goose goo and polluted water.

For what it is worth, both Mike Armstrong and Pam Johnston have lived in Acton for short periods of time, while Rob Barlow of Limehouse has been active in some facets of community action here.

Bob Malcolmson, a strong candidate, has said that Acton will have a fourth councillor if he is elected mayor. His work with the Chamber of Commerce has made him familiar with Acton's problems. Marilyn Serjeantson has also been involved in many of the positive decisions about Acton and been fair to the community.

This election, then, is going to be decided on the points voters see as most attractive to their expectations. Personality and profile will likely play a large part in selecting who will be the fourth mayor of Halton Hills.

Apartment owner now wants just 2 new units

Down-sized plans for an existing apartment building at 333 Queen St. are now being evaluated by various Town departments and outside agencies.

Initially, the owner of the building requested a zoning variance to legalize the 10 units he was renting in the building, that was only approved for six apartments.

Although the Town's Committee of Adjustment approved the plan, Council said no, based on staff's report that the 10 units did not conform to the Official Plan and that there isn't enough parking.

The owner has now resubmitted plans for two additional units to total eight apartments.

Municipal staff will schedule a public meeting on the revised application.
